- Help define technical analysis needs and costs
- Support technical consultant selection
- Membership

### Woodard Curran Agreement



- Approved February 2020- NTE \$163K
- Two year term
- Task Order (TOs) assignments to expedite assignment of budgeted work
- TOs via Steering and/or designated representative (Secretary)

### WC Agreement (cont.)



- FY 20/21 Budget included P68 revenue \$350K
- FY20/21 planned expenses for Workplan Component 3
  - a) Planning Activities. Two tasks
    - 1. DMS implementation \$50K
    - 2. Funding and Financing \$50K
  - b) Monitoring and Assessment \$225K
  - WC Task Order 2 to be issued for the DMS and Monitoring Work - \$275K (not attached)
  - NTE increase to \$437K

### **Todays Action**



- Adopt Resolution
  - Approve TO 2 amounts
  - Increase contract NTE to \$437K
  - Make the PW Director the designated representative to negotiate and sign TO 2

## Watershed Coordinator Grant



- Department of Conservation Program
- \$300K for 3 years
- No matching fund requirements
- Purpose retain a Watershed Coordinator to support GSP implementation
- Elements
  - Outreach
  - Monitoring
  - Technical support
- Due September 15

# DWR Draft PSP for GSP Projects



- \$26M in Round 1, \$62M in Round 2 in 2022
- Minimum of \$2M, Max of \$5M
- 25% cost share; Variable DAC waiver`
- One grant per basin

# DWR Draft PSP for GSP Eligible Projects



- Groundwater recharge
- Support water supply reliability, water conservation, water use efficiency and water banking, exchange, and reclamation
- Multi- benefits, multiple planning documents
